In accordance with the Texas Open Meetings Act, any response to a public comment that is made on an item that is not on the published final agenda will be limited to a statement of factual information or a statement of existing policy given in response to the public comment. Any deliberation or decision by the Board must be limited to a proposal to place the subject on a future agenda;
4. Public Comment on Agenda Items: Members of the public may comment on any agenda item listed below. Members of the public may speak for up to three minutes per agenda item on which they comment. Members of the public will speak on an agenda item after the item is called by the presiding officer, but before Board consideration of the item;

5. Discuss and consider action to authorize the Grant Committee to submit applications on behalf of the District for any grants for which the District is eligible and that the Grant Committee deems promote the District’s purpose;
6. Review and discuss Interlocal Agreement regarding fire prevention and inspection responsibilities with the City of Elgin and authorize associated action;
7. Discuss and consider action to appoint a District Fire Marshal’s Office;
8. Discuss and consider action to appoint a District Fire Marshal;
9. Discuss and consider action to appoint and commission Peace Officers; and
10. Discuss agenda items, time, and date for next meeting.
