

1. Pledge of Allegiance;
2. Call meeting to order;
3. Public Comment: In accordance with the Texas Open Meetings Act, any response to a public comment that is made on an item that is not on the published final agenda will be limited to a statement of factual information or a statement of existing policy given in response to the public comment. Any deliberation or decision by the Board must be limited to a proposal to place the subject on a future agenda. Members of the public may comment on any agenda item when that item is called by the presiding officer and prior to consideration by the Board. Public comment on a posted agenda item is limited to three minutes per person per agenda item;

5. Take a record vote on the District's 2019 tax rate, adopt an Order Levying Taxes, and authorize filing the Order with both the Bastrop County Tax Assessor/Collector and the Travis County Tax Assessor/Collector; and
6. Discuss agenda items, time and date for next meeting.
