A regular meeting of the Board of Commissioners of Bastrop-Travis Counties Emergency Services District No. 1 was held on **Thursday**, **January 18**, **2024**, at **6:30** p.m., at the Elgin Fire Station, 111 N. Avenue C, Elgin, Texas, for the following purposes:

Also present were ESD staff members, representatives of the Fire Department, representatives of the First Responder Unit, and members of the public.

- 3. <u>Public Comment</u>: Brian Henson addressed the Board. Nick Teague also addressed the Board.

5. <u>Discuss and consider election of officers</u>: Motion was made by Commissioner Doss for Commissioner Mogonye to be appointed Treasurer. Seconded by Commissioner McCullough. All in favor, motion passes.
